Georgetown University's Master of Professional Studies in Urban & Regional Planning emphasizes the integration of urban design with community development to create livable, meaningful, and sustainable neighborhoods, cities, and regions. Housed in Georgetown's state-of-the-art downtown D.C. campus, the program engages the communities, places, and professionals of the National Capital Region to study the process of urbanization as a worldwide professional endeavor. STUDENT EXPERIENCE

Students may complete the degree in 15 months (accelerated full-time), 2 years (full-time), or 3-4 years (part-time). Core Curriculum

18 credits

Core courses provide essential knowledge and skills for the practicing urban planner, including urban research, planning processes, regulations, law, ethics, models, and theory. The program emphasizes exemplary communication and analytic skills, which are essential to becoming an effective professional and an impactful leader.

- Housing and Community Development
- International Development
