COURSE DESCRIPTION

The emergency and disaster management discipline is increasingly faced with complexity--complexity in crisis situations, politics and policy, social vulnerability and resilience, community perceptions of risk, and more. These complexities can be addressed by collecting, analyzing, and disseminating data and results, and it is important to understand the different research approaches available to researchers and knowledge practitioners. It's also important to understand the different philosophical assumptions and interpretive foundations that frame our understanding. This course explores quantitative, qualitative, and mixed methods research approaches, drawing on the interdisciplinary literature that emergency and disaster management draws from. Students will conduct critical evaluations of research design and dissemination, and construct a research proposal for a topic of their choice. This course also explores the many ethical considerations taken when conducting research in the emergency and disaster management discipline.

COURSE LEARNING OBJECTIVES

By the end of this course, you will be able to do the following:

- Articulate the epistemological and practical differences in research approaches, and critique different approaches on their advantages and disadvantages
- 2. Identify an issue, problem, or knowledge gap and design an appropriate research framework to address the issue, problem, or knowledge gap
- 3. Synthesize and critically evaluate the state of the knowledge and research approaches in EDM through case studies
- 4. Employ appropriate analytical and dissemination techniques
- 5. Discuss the ethics of research in emergency and disaster management, and gain familiarity with Georgetown University's Institutional Review Board
- 6. Appraise the evolution of research and the interdisciplinary nature of emergency and disaster management

COURSE REQUIREMENTS

Technical Requirements

In this course we will use TurnItIn, VoiceThread, and Zoom.

- TurnItIn is a writing assessment tool that is used to detect plagiarism and allows teachers to provide assignment feedback to students. <u>Technical</u> support for TurnItIn is available.
- VoiceThread is a tool that enables teachers and students to upload and asynchronously present images, video, and/or other media and respond to others presentations with audio, video, and/or text comments. <u>Technical</u> support for VoiceThread is available.

COURSE EXPECTATIONS

This course is conducted entirely online, which means students do not have to be on campus to complete any portion of it. Students will participate in the course using Georgetown University's online learning management system called Canvas. Each new module that is released will open on a Tuesday at 11:59 pm (ET), two weeks before the module formally begins. Students are required to move through each module in sequential order. This course consists of 10 modules.

Student Expectations

At the beginning of each module, preview the module so that you can plan your time accordingly. Take note of the various readings and assignments with their due dates. Notice whether assignments are individual or group assignments so that you allocate time for communication and collaboration. Be aware that many modules end with a substantive assignment.

Participation is essential to your success in this class. You are expected to engage actively in discussion boards, complete all module activities, and collaborate on group and class assignments. The quality of your participation does contribute to your grade in this course.

Present yourself as the professional you are or aspire to be. Do good work, proofread what you write, and communicate respectfully. Remember, your classmates are your future colleagues.

As a Georgetown University graduate student, you are expected to put forth your best efforts in completing the course readings, assignments, and activities.

Time Expectations

Our online classes are designed to meet the same time requirements as our place-based (face-to-face) courses. For a 3-credit, 15-week course, students should expect to spend approximately 9-12 hours per week participating in the course and completing all course assignments.

There are no excused absences in an online course.

COURSE ACTIVITIES AND ASSIGNMENTS

Each module includes readings and other materials, discussion boards for engaging with your peers around the course content, and assignments that provide an opportunity to apply your newly acquired knowledge and practice important skills.

Students are expected to participate in all course-related activities.

There are four synchronous sessions planned for this course: an orientation session near the beginning of the course, an interview of an emergency manager, a mid-semester check in, and a final project check-in. Additional synchronous sessions may be added to accommodate guest speakers. Synchronous sessions will be recorded, and students who are unable to attend the live session are required to view the recording. Dates and time of synchronous sessions will be announced through Canvas. Students must notify me in advance if they are unable to attend a synchronous session, and they may be given an alternate required assignment.

Written work is due by the assigned due date on Canvas. You must submit your weekly written assignment online by the time assigned in Canvas; do not send your papers to other personal or professional email addresses. Follow-ups and class participation is contingent on the timely submission of your initial responses.

All written assignments should be in a standard 12-point font and double-spaced with 1 inch margins, unless otherwise indicated. Reference lists do not count toward page requirements. All written assignments should conform to the APA style guide.

Note that discussions typically have two due dates: a date for the initial post, and a date for replies to classmates. Only the initial post due date will appear on the calendar and assignment page. The response due date is included in the discussion board instructions. You are responsible for meeting both due dates.

Late Submission Policy:

Work is due by the due dates set in Canvas.

If you have extenuating circumstances, please speak with me as soon as possible, and always in advance of the deadline. Turning in work late, even with instructor approval, may result in a reduction of your grade.

Assignments

There are a variety of assignments in this course, including reading notes, discussions, and papers and written assignments. All of these assignments are explained in detail within the Canvas platform. You will also find the corresponding grading rubric under the assignment instructions; for discussion boards, click on the gear icon to view the rubric.

Annotated Bibliography: (25% of your grade)

During this course, you will be asked to compile an annotated bibliography. Most modules contain an assignment which in which you will complete some work toward you final annotated bibliography by locating an established number of articles, writing

annotated bibliography entries for each of them, posting the entries to the discussion board, and reading and commenting on other posted entries.

Final Project: (15% of your grade)

Due: Modules 9 & 10

After choosing a research topic, you will develop a full research proposal including a literature review, methodology, research framework, and data collection and analysis. You will complete work towards you final proposal throughout the course, including building to your annotated bibliography and completing writing assignments which will inform your final proposal. At the end of the course, you will complete peer reviews of the proposals and prepare a presentation of your proposal to your instructor and peers.

Discussions: (15% of your grade)

In each module, you will be presented with a prompt relating to the reaching materials for the module. You will be asked to share an initial discussion post and respond to at least two of your peers' reflections.

Writing Assignments: (35% of your grade)

In several modules, you will be asked to submit a writing assignment, each of which informs and/or builds towards your final research proposal. These written assignments will include initial compilations of your annotated bibliography, ethical considerations for your proposal, and research critiques.

Read/Watch and Discuss: (10% of your grade)

In each Read or Watch and Discuss assignment, you will be presented with an article or case study and asked to evaluate it in the context of the materials and considerations of the module. You will be asked to both complete an initial post and provide feedback to some of your peers' responses.

Georgetown Library

Students enrolled in online School of Continuing Studies SCS coursework have access to the University Library System's eResources, including 500+ research databases, 1.5+ million ebooks, and thousands of periodicals and other multimedia files (films, webinars, music, and images). The Library does not mail physical items to students.

SCS students may make an appointment with a librarian to discuss a research topic, develop a search strategy, or examine resources for projects and papers. Librarians offer an overview of and in-depth assistance with important resources for senior or master's theses, dissertations, papers and other types of research. Appointments are conducted using Google Hangout (video-conferencing function) through the Georgetown Gmail System or by telephone.
