Course Description

This course first develops simple graphical and mathematical models of decision-making by individual economic agents: consumers, workers, and businesses. We analyze interactions between these agents in product and factor markets using concepts of market demand, supply, and equilibrium. Finally, we demonstrate the efficiency of perfectly competitive markets, describe the conditions under which that efficiency arises, and examine market failures that occur when those conditions are not met.

Course Objectives

The objective of this course is to introduce the student to the basic tools of economic analysis and economic reasoning. A successful student end the course with basic understanding of the interplay between individual behavior and aggregate resource allocation through the market mechanism. The student will also gain insights about the implication of different government policies as well as different market structures such as minimum wage policies, etc.

Course Structure

The following are the big areas this course would cover. The exact topics in each area will vary depending on time and your interests.

- 1. Introduction to Economics
- 2. How Markets Work
- 3. Markets and Welfare
- 4. The Economics of the Public Sector
- 5. Firm Behaviour and the Organisation of Industry
- 6. The Economics of Labour Markets

Grading Policy

The course grade is determined by the following components:

- Midterm 30%
- Final 40%
- Assignments 20%
- Class Participation 10%

There will be weekly assignments related to the topics covered in that week and will help reinforce key concepts discussed in class. There will be one midterm and one final exam. The midterm will take place in the third week, and the final will take place on July 8th. All exams are closed-book. Makeup exams are possible under certain emergency circumstances.
