### COURSE DESCRIPTION

This course is structured around the lectures of Professor Garance Genicot.

This course aims to provide students with a comprehensive and formal understanding of the fundamental principles of microeconomic analysis introduced in their micro principles course (Econ 001). While students may have some prior exposure to topics like consumer theory, equilibrium analysis, externalities, and public goods, this course offers a structured and in-depth approach to these concepts. Additionally, topics like game theory may be new to students. The primary objective of the course is to equip students with essential concepts and analytical tools that will be useful for advanced economics courses, as well as to preview significant topics.

The analysis will involve some mathematics, which is necessary for a modern approach to microeconomics. However, graphical techniques will also be emphasized in class to aid in building intuition.

Attending to OH is optional.
