# Course Description

Welcome to our exploration of statistics and economics! This course provides a comprehensive overview of descriptive statistics and probability theory before delving into the subject of statistical inference. You'll acquire the necessary foundation for Introduction to Econometrics (Econ 122). Topics include probability theory, descriptive statistics, estimation, hypothesis testing and confidence intervals. Throughout the course, we will use STATA, a statistical software, to better understand the topics. We'll also have hands-on experience with electronic data acquisition and analysis. Our weekly lab sessions provide an opportunity for you to discuss homework assignments and practice using computer software.

## **Course Objectives**

By the end of this course, students will be able to:

- Understand and apply basic concepts of probability and statistics
- Analyze and interpret economic data using descriptive statistics
- Estimate population parameters and test hypotheses using sample data
- Construct and interpret confidence intervals for population parameters
- Use STATA to perform basic data analysis tasks

### **Prerequisites**

This course requires a basic understanding of calculus. For those who may need a refresher, a review of the necessary concepts will be provided at the beginning of the semester. The review will cover topics such as limits, derivatives and integrals to ensure that everyone has a solid foundation for the course material.

#### **Textbook**

The required textbook for this course is "Probability and Statistical Inference", 10th edition, by Tanis, Hogg and Zimmerman (9th edition will also work).

# **Grading Policy**

Grades will be based on the following components:

- Problem Sets (20%) Due weekly. Half of the points will be based on effort and half of the points will be based on accuracy for a randomly selected question.
- Midterm exam (30%) June 20th, 2023
- Final exam (50%) July 6th, 2023

- Week 5 (July 3 July 6): Ch.8 Tests of Statistical Hypotheses
