AND

2) Copy of a bank statement or bank letter in English and on official bank letterhead indicating the type of account, the current balance, and type of currency. Current balance must appear in numeric figures. The name of the family member providing support must appear on the bank document. All funds must be immediately available by the program start date.

\$ _____ **SPONSORING ORGANIZATION FUNDS**

Documentation required: Copy of a letter in English from a sponsoring organization that indicates the amount of funds to be provided and the duration of the award.

\$ _____ **LOAN FUNDS**

Documentation required: Copy of the approval letter indicating the amount of the loan.
